

FROM THE DESK OF FATHER JOHN



Jesus would have made a great trial lawyer. He never lost an argument and often turned the accusations of His accusers back on them. This is seen clearly in this week's Gospel showing the trial of a woman caught in the act of committing adultery. In an attempt to accuse and trick Jesus, the scribes and the Pharisees place before Him a woman caught in the very act of committing adultery. They ask Him if it is lawful to stone her.


According to the law of Moses, this was the prescribed punishment at the time. The question was used as a ploy by the Pharisees because no matter which way Jesus answered, either yes or no, He would face consequences. If Jesus sided with the law of Moses, He would be ignoring Roman law which didn't allow the Jewish authorities the right to capital punishment. If Jesus chose not to put her to death, He would be ignoring the law of Moses. Despite the Pharisees' clever scheme, Jesus doesn't take the bait. When pressed for an answer, Jesus doesn't go along with the mentality of the mob or the emotions of the crowd, rather in an unprecedented move, He bends down and begins to write on the ground.

This must have been very strange for everyone present. People must have asked, "What is He doing?" We don't know exactly what Jesus was writing on the ground, however, it is surmised by the early Church fathers that Christ was writing the sins of those who were accusing the woman. Through this simple action, Christ defused the anger of the Pharisees and diverted the malice of the crowds. He doesn't immediately respond to their pressing question and turns their question back on them with His reply. In a brilliant maneuver and with the wisdom of God, Jesus gives His response, "Let the one among you who is without sin be the first to throw a stone at her." (John 8:7)

Christ doesn't accuse the woman nor does He condemn those who brought her to Him. Instead, He brings them to acknowledge their own sinfulness. They recognize that they are no different or superior to the woman who they are accusing. There is no one without sin, except of course the one who would be condemned, Jesus Himself. None of those making the accusations were in a position to condemn the woman. The Gospel writer mentions, "And in response, they went away one by one, beginning with the elders." (John 8:9)

Like those in the Gospel for this week, we are all sinners in need of God's forgiveness. This Gospel passage and the Gospel passage of the Prodigal Son from last week, demonstrate to us that there is no limit to God's love and forgiveness. May we not take the gift of His forgiveness for granted, and may we never tire of approaching Him in the Sacrament of Reconciliation, especially this Lent.

MEDITACIÓN DEL PADRE GUSTAVO



En la historia de la mujer adúltera escuchamos esta frase "Aquel de ustedes que no tenga pecado, que tire la primera piedra". Jesús en lugar de caer en la trampa que le tenían los escribas y fariseos solo se inclina y escribe algo con el dedo en la arena. Le concede el perdón a la mujer y le dice no peques más. Esta es la escena de la mujer adúltera perdonada. El pecado del que acusan a esta mujer, Dios lo ha perdonado. Vemos como trabaja la misericordia de Dios. Dice San Agustín "quedaron la misericordia y la miseria". La miseria humana y la misericordia divina tienen un fugaz encuentro. Esta mujer recibió la mejor mirada de misericordia que limpia y renueva todo su ser con la total confianza de ser una hija de Dios. Como cristianos debemos anteponer la misericordia al juicio y en cualquier caso, el juicio de Dios tendrá lugar siempre a la luz de la Misericordia. Recordemos siempre que Jesús es el cordero de Dios que quita todos los pecados del mundo. Jesús a través de los sacerdotes, sigue diciendo "yo te absuelvo de tus pecados" en este momento entra el canal de la misericordia, Es el mismo Cristo que sigue perdonando a un pecador arrepentido en un confesonario. Todo pecado es borrado por la misericordia de Dios. San Juan Pablo II en su Exhortación Apostólica Reconciliación y Penitencia, define el sacramento de la penitencia como: Es el momento en el que, en respuesta al penitente, la Santísima Trinidad se hace presente para borrar su pecado y devolverle la inocencia, y la fuerza salvífica de la Pasión, Muerte y Resurrección de Jesús es comunicada al mismo penitente como "misericordia más fuerte que la culpa y la ofensa", según la definí en la Encíclica Dives in misericordia. Dios es siempre el principal ofendido por el pecado, y sólo Dios puede perdonar. Por esto la absolución que el Sacerdote, ministro del perdón, aunque él mismo sea pecador concede al penitente, es el signo eficaz de la intervención del Padre en cada absolución y de la "resurrección" tras la "muerte espiritual", que se renueva cada vez que se celebra el Sacramento de la Penitencia. Solamente la fe puede asegurar que en aquel momento todo pecado es perdonado y borrado por la misteriosa intervención del Salvador. San Pablo a los Filipenses escribe "Por causa de Cristo lo he perdido todo y lo considero basura a cambio de ganarlo a El y encontrarme unido a El". Lo que si hago es olvidarme de lo que queda atrás y esforzarme por alcanzar lo que está delante. Él lo dejó todo por Cristo y no se arrepiente. Y una de las consignas del apóstol Pablo era trabajar en hacerse semejante a Cristo en su muerte. Por lo tanto, ya se acerca la pascua en la que todos juntos caminamos hacia el cambio y la renovación a una vida nueva en Cristo después de su muerte y resurrección.


